Release of Liability, Indemnification and Consent Agreement

I, the undersigned, do hereby give full consent and approval for myself and/or as the parent/guardian of the Minor player listed below (the “Minor”), if any, to participate in Stillwater All Sports Association events and activities.

In consideration for such participation in Stillwater All Sports Association (SASA) and the right to participate on the team designated by SASA and to use SASA facilities as instructed, I, on behalf of myself and/or the Minor, understand, agree, accept, certify and/or assume the following: -That the very nature of sport is hazardous and there are certain risks of damages and injury, including death, inherent in the participation in any SASA event, as well as risks related to travel and in other related activities incidental to participation, and am willing to assume any and all such risks, injuries and damages. Such risks include, but are not limited to, those hazards associated with weather conditions, travel, playing conditions, field and facility hazards, hazards related and incidental to sport activities, including but not limited to collision, injury, actions of other participants or health which I acknowledge and understand is dangerous to myself or the Minor and other players and may result in serious harm or death. - That I, on behalf of myself and/or the Minor, solely assume any and all risks of injury or harm incurred or suffered by myself or to the Minor listed below in any way (a) while practicing or playing in SASA activities, events or on SASA facilities, (b) while serving in any non-playing capacity, and (c) while on or upon the premises of any and all of SASA’s fields/courts arranged by SASA or the team or the league for play or practice. – That the participant is fully capable of participating in SASA activities and events and is in sufficient physical and mental condition to allow full participation in SASA activities and events without undue risk to my or the Minor’s health, except as made known to SASA Directors, the coaches, and officials of the team and league. -That I acknowledge the risk of direct or indirect contact with individuals who have been exposed to and/or diagnosed with one or more communicable diseases, including but not limited to COVID-19 or other medical conditions, diseases, or maladies, and/or any mutation or variation thereof that may exist and it is impossible to eliminate such risk and that I or the Minor could become infected through contact with, or close proximity to, an individual with a communicable disease. I, on behalf of myself and the Minor, do hereby waive, release, discharge, and agree not to sue and to further indemnify SASA, its volunteers and employees, the owner or operator of any field or other entity connected with SASA, the team, league, field or association for any damages, harm or injuries, including death or materialized risk associated with any SASA activities or events, whether known or unknown, sustained or incurred by myself or the Minor from whatever cause, including, but not limited to, the negligence, breach of contract, and/or wrongful conduct of the parties hereby released (whether in whole or in part and whether the only contributing factor or only a contributing factor). I, acknowledge that I have read and understand each and every one of the above provisions in this Release of Liability, Indemnification and Consent Agreement and that by signing this I am certifying that I will fully comply with this Release of Liability,

Indemnification and Consent Agreement and with any and all SASA rules, that I further agree to explain and enforce the provisions of this Release of Liability, Indemnification and Consent

Agreement to and with the Minor, along with assuming responsibilities and risks on such participant's behalf and understand that if I do not comply with this Release of Liability, Indemnification and Consent Agreement or other SASA rules, I or the Minor will be subject to sanctioning or removal from play at SASA's sole discretion. I further understand and agree that SASA shall not be responsible for matters outside of its control, including but not limited to weather or facility conditions and agree to abide by the decisions of SASA volunteers and staff regarding the timing, number, use and playability of SASA activities, events and/or facilities. I understand and acknowledge that any SASA activity or event may be changed or canceled, with or without resumption or rescheduling, at the sole discretion of SASA volunteers or staff.

This agreement shall be binding on me, the Minor, and upon each respective heir, legal representative, or assign thereof. By signing below and/or participating in SASA activities or events, or using SASA facilities, I acknowledge, agree, verify and accept the statements set forth hereinabove on my behalf and on behalf of the Minor listed hereinbelow, if any.
